First I'd like to wish all our members a happy and prosperous 2012! I hope each of you enjoyed a warm and fulfilling holiday season that serves to nourish and inspire you throughout the New Year.

As you probably know from previous FAO e-mail messages, in September, there was an unprecedented action taken by the AAO BOT approving a motion that the AAO president be one of the signatories on a letter to state BOD's advocating reciprocity and portability of licensure between states. This action greatly concerned the FAO leadership since it was diametrically opposed to our efforts at our own BOD (over the past six years) to maintain quality (continuity) of care for future orthodontic patients in Florida.

As a result of our (and others) response, the AAO BOT reconsidered and voted instead to send the issue to several councils for consideration.

On November 9th, a survey was sent by the AAO to 63 members (component presidents and others unnamed). The survey included no additional information pertaining to the issue. It consisted of 3 questions and one area for comments. The response rate was 39.6%.

The only question with a significant majority response was:

*"Should the AAO adopt a positive position on the portability of specialty licenses between states and actively encourage states to adopt such policies?"*

Out of 63 surveyed, 20 responded yes to the above and 5 responded no.

Subsequently, the FAO prepared and the SAO submitted a different survey for component presidents of just the SAO district, including additional points to consider (facts that were not likely considered by the twenty respondents above). As part of our mission, your FAO leaders will continue to defend against any threats to the highest possible quality of care in our state and uphold those principles that bring us together each year as one of the largest component organizations in the country.

# Orthodontic Legislative Update

## New Year – New Session

With the 2012 Legislative Session starting January 10, below is my countdown as to what this session is expected to bring.

### 1. New Legislative and Congressional Districts

Every 10 years Florida must undertake redistricting and reapportionment based on the newest federal census data. The Florida Legislature has met all summer working to redraw district lines to reflect changes in population and demographics. Despite all this pre-session work, this issue is expected to take up most of the legislation session, and hold many other issues hostage. Redistricting brings a whole new meaning to the term “horse trading”. Many key district lines get drawn in concrete versus sand once key votes are exchanged. Throwing a monkey wrench into the process are constitutional amendments previously passed by Florida voters making it tougher to draw Senate and House boundaries. Who will be the final decision maker on new districts? Many legislators feel ultimately the Florida Courts will have to settle the issue just in time for the November elections.

### 2. Florida’s Budget

Like every legislative session, one thing that must be accomplished is finalizing the State Budget for the upcoming fiscal year. What hasn’t changed though? Florida is once again in another budget shortfall, predicted to be \$2 billion. The Governor’s proposed budget recommendations included more cuts to State health care programs, including further cuts to hospital funding and more dollars to the state education system. Once again on the Medicaid cutting block, the Medicaid adult dental program. Other funding limits proposed include limits on primary care visits and emergency room visits for Medicaid recipients.

### 3. And Speaking of Medicaid....

Medicaid Reform will once again be on the front burner for the Florida Legislature, and once again dictate much of the State budget. The federal government has approved the continuation of the 5 county Managed Care Medicaid pilot, and the Agency for Health Care Administration (AHCA) says it will now focus on federal approval of the statewide expansion to managed care. AHCA is also complete now with the appointment of Justin Senior at the helm as the new Medicaid Director.

### 4. Legislative Tracking Watch List

SB 1040 by Senator Bogdanoff (HB to be filed by Rep Corcoran)

This proposed legislation, if passed, would allow dental hygienists, with additional training, to administer local anesthesia under the direct supervision of a dentist (patients must be non-sedated and at least 18 years of age). The training will include 30 hours of didactic training and 30 hours of clinical training, and implementation will be at the discretion of each dental office.

### 5. Gambling

As if redistricting and the State Budget wasn’t enough, it is expected that the Florida Legislature will tackle another hot and controversial issue, expansion of gambling and/or the addition of resort casinos in the state. Though this has nothing to do with the orthodontic world, it is expected to be an issue that will continue to take up much of the Legislature’s energy, with groups such as the Las Vegas Sands pushing to open shop in Florida. Some legislators are entertaining the idea as a way to deal with Florida’s budget crisis.

### 6. Specialty Licensure for Oral and Maxillofacial Surgeons

This issue was discussed at the last Board of Dentistry meeting, and though no legislation has been filed for the 2012 Session, we will continue to monitor and alert leadership if any legislation dealing with this issue appears this session.

### 7. Dental Schools

Also on our watch list over the summer and also into the Legislative Session is the proposals to expand dental schools in Florida. FAO will continue to lend our voice to the FDA as they work to address this with policy makers in the most appropriate manner.

With 7 being a lucky number we will end our countdown here, and will keep FAO posted as the 2012 Session goes into full swing!
